

IMPORTANT INFORMATION

CONCERNING TRAFFIC SAFETY SCHOOL

EFF. JULY 1, 2013, DRIVERS CHARGED WITH SPEEDING, WHEN OPERATING A VEHICLE IN AN URBAN DISTRICT AT A SPEED IN EXCESS OF 25 MILES PER HOUR OVER THE POSTED SPEED LIMIT ARE NOT ELIGIBLE FOR TRAFFIC SAFETY SCHOOL.

Pursuant to Public Act 97-831 the provisions of Court Supervision [paragraph (c) of 730 ILCS 5/5-6-1] shall NOT apply to a defendant charged with violating subsection (b) of Section 11-601 of the Illinois Vehicle Code when the defendant was operating a vehicle, in an urban district, at a speed in excess of 25 miles per hour over the posted speed limit.

THIS PROCEDURE DOES NOT APPLY TO CDL HOLDERS.

Effective September 30, 2005, Senate Bill 1825: In accordance with 49 C.F.R. Part 384, all reports of Court Supervision, except violations related to parking, shall be forwarded to the Secretary of State for all holders of a CDL (Commercial Driver's License). These reports shall be recorded to the driver's record as a conviction for use in the disqualification of the driver's commercial motor vehicle privileges and shall not be privileged information.

EFF. JANUARY 1, 2008, THIS DOES NOT APPLY TO DRIVERS UNDER AGE 18.

Public Act 95-310 prohibits drivers under 18 years of age from participating in the mail-in process. Drivers under 18 years of age should plead not guilty and request a court date. Drivers under 18 years of age must have a parent present in Court before Court Supervision will be granted.

TRAFFIC SAFETY SCHOOL INSTRUCTIONS

Complete this side only if you chose box B.

Fees and registration form must be received and processed by McLean County prior to attending class.

Classes are offered on Wednesdays and Fridays from 6-10PM or on Saturdays from 8AM-12PM or 1-5PM. Classes are held in McLean County at Heartland Community College, Normal, Illinois.

OUT-OF-COUNTY/OUT-OF-STATE DEFENDANTS - To attend class in another state or county, choose box "B". You must still pay all fees listed next to box "B" to the CLERK OF THE CIRCUIT COURT OF MCLEAN COUNTY. Complete the Registration Form below. Make sure to mark Yes in the box under Option 2.

If you choose to attend traffic safety school in another location, you are responsible for locating and completing the course. You must also pay the additional registration fees at the defensive driving school where you choose to take the course. **NOTE: Online classes do NOT meet McLean County requirements.**

TO REGISTER - Complete the Registration Form below. This form must be received by the CLERK OF THE CIRCUIT COURT before the date on your citation (ticket) with your \$165 (non-refundable), unless the citation (ticket) is for speeding 21-30 mph over the speed limit, then pay \$185 (non-refundable). Make your personal check or money order payable to the CLERK OF THE CIRCUIT COURT. Do not send cash. Mail this envelope before the date on your citation (ticket). Please allow 5 business days for mail delivery.

TRAFFIC SAFETY SCHOOL - Your class assignment form will be mailed to you from Heartland Community College. You should receive your class assignment in 2-4 weeks from payment date. Your request for class day and time will be honored, if possible. If you cannot attend your assigned class, immediately call Traffic Safety School and reschedule. To reschedule at no fee, call no later than the reschedule deadline date printed on your class assignment form. After that date the rescheduling fee is \$25. If you miss your class, you must reschedule a new class and pay \$25. If you have questions about Traffic Safety School contact their office at (309) 268-8159 between 8:00AM and 4:00PM, Monday-Friday.

Traffic Safety School will report to the court when you complete class. No driving conviction will be reported to the Secretary of State.

COURSE COMPLETION GUIDELINES - The McLean County Circuit Court REQUIRES that you complete your traffic safety school class at least 30 days before your supervision termination date. If you take the class outside of McLean County, you must mail your ORIGINAL certificate of completion to the Traffic Safety School. The certificate must be received in the Traffic Safety School Office at least 30 business days before your supervision termination date. Failure to comply will result in a conviction being placed on your record.
